Scope of work:-

Supply of Agriculture labourers for (A) Sugarcane cutting, cleaning, binding, shifting to loading spot (B) Sugarcane only loading to Trucks/ Tractor from different areas in each shift.

- 1. The contractor has to engage agriculture labourers for sugarcane cutting, cleaning, shifting and loading to trucks at different Cane Field in each shift, as per requition of Cane Development Assistants in 3 shifts per day, each of 8 hours.
- 2. The Contractor shall not engage labour below 18 years age & above 50 years.
- 3. The Contractor will engage labourers under Cane Development Department of A.C.S.I. Ltd. Nuagam, Aska.
- 4. The contractor should engage labours for cutting, shifting and loading of sugarcane as per direction of Cane Growers/CDA/CDS failing which quantum of penalty would be levied as per the decision of the Management.
- 5. Proportionate deduction will be made in case of less or failed to supply labour.

Terms & Conditions:-

- 1. No Advance payment will be made. The contractor has to make payment to the labours at 1st in their Bank Account and on submission of proof for payment, the industry will release each Fortnight/15 days the payment of that concerned for amount.
- 2. The payment will be made Fortnight/15 days (as per Cane Price Bill) only as per the record maintained by contractor and upon submission of Bill duly forwarded by CDS and certified by Cane Manager.
- 3. Income tax as per Government Rules will be deducted from the bill amount. EMD will be refunded after closure of the season without any interest.
- 4. Any law existing or likely to be enforced by the Government and if it requires any compliance, shall be lookout of the contractor only.
- 5. The contractor has to submit the list of the manpower details, address proof of all labours duly attested by the contractor & insurance certificate before the Security Office of the Industry for issue of identity card for their identification at working place.

- 6. The Contractor has to submit a copy of the PAN card, GST No & EPF registration before payment of the first bill.
- 7. The tools and tackles required to perform the work at Cane Field shall be the scope of the Contractors.
- 8. Adequate Safety equipments/measure to the labour is scope of the Contractor.
- 9. The Contractor shall not pay below the minimum wage recommended by the Govt. from time to time.
- 10. The Contractor shall submit the Muster Roll copy of his labourer of the concerned bill period while claiming for bill payment.
- 11. Other Terms' & Conditions are laid down in the Tender Call Notice.
- 12. The Authority also reserves the right to terminate / cancel the work order at any stage in case you fail to meet the above indicated conditions and EMD shall be forfeited.
