The bidders should submit Bids in two sealed envelopes i.e. one containing Technical Bid consisting all technical details and other containing Financial Bid. Both the covers should be placed in a single sealed cover superscripting “AMC for 40 ton & 10 ton weigh bridge and Mobile No. on the cover.

**Scope of work.**

AMC of Electronics Weigh bridges Global make 40 MT (01No for Trucks) , 10 MT (02Nos.for carts) & Eurotech make electronic weigh bridge 80 MT(01 No. for Trucks) comprising yearly servicing & stamping work. AMC will be valid for one year.

**Technical bid.**

- 1) Vender should be well experienced (minimum 3 yrs of experience) & authorization as per norm of legal metrology which proof to be furnished in technical bid.
- 2) Preference will be given to OEM /authorized service provider as per discretion of management against submission of valid documents.
- 3) The Tenderer are required to submit 5,000/- ( Five Thousands only)as EMD (refundable without interest) & cost of tender paper Rs. 590/- both in the shape of demand draft payable in favour of Managing Director, Aska Co-operative Sugar Industries Ltd., Aska in any Nationalized Bank. The EMD will be refunded without interest to the unsuccessful Tenderer after finalization of the tender. The Tender Form can be downloaded from our website. **Other terms & condition.**


- 1) You have to complete the Overhauling/Calibration works of the Weigh Bridge before starting of the Crushing season.

- 2) The Stamping and Calibration work of the weigh bridge is to be arranged by you. The required Stamping & Verification fees are to be paid by the industry.
- 3) Test weights will be arranged by the industry.
- 4) Only Unskilled Laborers along with shifting arrangement for handling of test weight required in Overhauling & stamping work is to be provided by the industry.
- 5) You have to depute service engineer quarterly (04 times including stamping) for preventive maintenance within the contractual period.
- 6) You have to depute your service engineer annually to prepare and produce weighbridges for calibration and stamping by Legal metrology authorities.
- 7) Besides preventive maintenance, in case any breakdown you have to attend the Rectification /Repair of the Weigh Bridges within 12 Hours after getting the information from our end.
- 8) All spares and replacement of detective parts will be arranged by industry.
- 9) Free lodging will be provided to the service engineer during his visit.
- 10) Tenderers are required to keep watching the website [www.askasugar.com](http://www.askasugar.com) for any changes to the tender.
- 11) The rates so finalized shall remain firm for the entire specified period and the successful bidder can't claim for revision of rate in the middle of the contract period.
