Lifting of process Chemicals and general cleaning Chemicals (Caustic Soda) etc. for the Crushing Season 2025-2026.

- 1. Contractor has to lift of Sulphur and process Chemicals from General Store to work place and remove empty jars to General Store.
- 2. Lifting of Common Salt, Caustic Soda and Washing Soda from General Store to work place during general cleaning 2025-2026.
- 3. Lifting of Caustic Soda to D.M. Plant.
- 4. The Contractor should not engage labour below 18 years' age & above 50 years.
- 5. The Contractor has to arrange Safety materials & follow Safety precaution rules on his own risk while executing the works.
