SCOPE OF WORK: -

Preparation of milk of lime and removal /shifting of lime grit and stone for the Season 2025-2026.

- 1. Preparation of milk of lime in "3" shifts per day at 7 ° Baume for process.
- 2. Milk of lime will be added in injection out let water channel and ETP water channel to maintain required PH.
- 3. All empty bags collected from the above works are to be made in a bundle of 25 each and kept at factory site near lime Godown.
- 4. Removal of lime grit and stone should be shifted from lime classifier, vibration screen and lime slacker, then & there without any accumulation and to be lifted & filled up in low land area of factory.
- Lime Grits and Stones will not be allowed to Contractor to take outside without knowledge of Senior Manager (process).
- 6. The contractor should not engage labour below 18 years of age & above 50 years.
- 7. The contractor will have to bring lime bags from the factory lime Godown by his labour. No extra labour will be for repacking the powder lime.
- 8. The contractor has to arrange Safety materials & follow safety precaution rules on his own risk while executing the works.

Terms & Conditions: -

- 1. No advance payment will be made before completion of works.
- 2. The payment will be made on shift wise basis of work only. If milk of lime solution is not prepared in any shift, payment will not be made for that shift.
- 3. The contractor has to make insurance for the workmen engaged and he is fully responsible for any accident/injury /loss occurs to them during execution of above job.
- 4. All safety materials are to be arranged by the Contractor like Mask & Coconut oil.
- 5. The payment will be made monthly (basing on calendar month) only as per the record maintained by the shift Chemist/Senior Manager (process).
- 6. Security deposit 5% and income Tax as per Government Rules will be deducted from the bill amount. The security deposit will be refunded after closure of the season on satisfactory performance of the above job, certified by Senior Manager (process)
- 7. You are to abide by relevant labour laws as required and submit the labour Licence and Insurance policy for workmen within a week in the Concern office after receipt of the work order failing which the work order will be cancelled.
- 8. Any legal complicacy, while working inside the factory will be look after by the Contractor.
- 9. The Contractor has to submit the list of manpower details, and proof of all labours duly attested by the contractor & insurance paper in the security office of the industry for issue of identity card for identification at factory gate.
